

Recycling plastic packaging

All 16 Somerset recycling sites can now take rigid plastic food and other household pots, tubs and trays (PTT) in the skips also used for plastic bottles.

Plastic bottles remain the only plastic we can accept at the kerbside, so please do not add PTT to kerbside recycling boxes.

It is planned to add new materials, such as PTT, beverage cartons (tetrapaks), batteries and small electrical items to the kerbside collections, as the [Recycle More](#) service rolls out from 2020. We're working hard to procure a new contractor, new vehicles and improved depots to enable this.

Suitable for recycling at all recycling centres:

- Plastic pots for yoghurt, soup, face cream, hair gel.
- Plastic tubs for margarine, ice cream, laundry tabs.
- Plastic trays (including black plastic) for meat, ready meals, and plastic punnets for fruit and mushrooms.

Please **remove** all foil, film covers, absorbent pads and card. Rinse out any contents and squash items to fit more in the skips.

Not suitable for recycling are plastic films, such as cling film, bubble wrap, carrier bags and film covers; plastic paint pots, plant pots or seed trays; or other plastics, such as toys, garden furniture, car parts, CDs, DVDs, VHS cases or tapes.

Pledge against Preventable Plastic

Recycle More procurement

The procurement process for the new Recycle More kerbside service (extra materials collected weekly for recycling and rubbish collected every three weeks) was launched in May. Over the summer and autumn SWP will be in dialogue with the selected suppliers. To ensure that [Somerset Waste Board](#) can review the outcome of the first stage of the competitive dialogue process and any changes to the final specification, an additional Board meeting has been arranged for 19 October.

Safe gas canister disposal

Viridor, SWP's recycling site contractor, has been running a national campaign to remind the public of the dangers of unsafe disposal of gas canisters, including smaller camping cylinders and those used for garden heaters and grills.

Ahead of summer barbeques, when residents may be purchasing new gas cylinders, residents are reminded **NOT** to dispose of gas cylinders in their refuse bins but to return these to their gas retailer. Alternatively, for a [small fee](#), spent gas cylinders can be taken to a [recycling centre](#).

Incorrect disposal of gas canisters that still contain flammable liquids and gases can lead to dangerous and costly explosions and fires if they are crushed or broken in rubbish trucks, at recycling centres or on landfill sites. Other risky items in rubbish bins include: hot coals, batteries aerosols. Our advice:
