## Pitcombe Parish Council

Minutes of the Pitcombe Parish Council meeting held on Tuesday 11th November 2025

**Present:** Cllr Groom, Cllr Hutton, Cllr Hartnell, Cllr Shylan,

In attendance: 5 Members of the public, Mrs Tuck, clerk Cllr Trimnell arrived late having attended

another council first.

Cllr Groom agreed to Chair the meeting, opened the meeting and welcomed those in attendance explaining that we had to cancel the October meeting as we had not been quorate. The Council currently only has 4 Councillors – we need 3 to attend so a meeting can go ahead, last month due to unforeseen circumstances we only had 2 Councillors who could attend.

2025.81 Apologies Cllr Power, Mrs Fone, footpaths officer

**2025.82 Declaration of Interest –** Cllr Shylan – Lancombe Lane work.

**2025.83 Minutes of the last meeting:** were read and an amendment requested so these will be signed at the December meeting.

**2025.84 Matters Arising:** The road between Cole the bridge over the River Pitt has been repaired again. The water running over the road needs to be repaired Wessex Water say there is no hydrant. There is a pipe under the road which may be blocked but Highways can't repair whilst the water is running over it or is it a spring? Cllr Hutton will contact to Wessex Water again.

Grove Cross to grove Farm, CCTV cameras were put in 4 weeks ago by Council. The clerk has emailed Somerset highways about the road surface around the drains with no response.

No news about bat emergence from Under the river bridge. Mr Jennings has put a gate across Lancombe Lane to stop motor bikes, he spoke about peoples lac of respect for animals wit people frightening his sheep, people are walking their dogs off the lead in Rye Ash Field whilst his sheep are I situ, despite him putting up 3 new signs. If this continues he will padlock the gates at both sides of the field.

The Chairman of Bruton Town Council has agreed we can have use of their sid but said we have to get Highways to agree the site and put a pole up, which we will have to pay for. Clerk asked to enquire of Highways about cost of a pole on the triangle opposite the noticeboard on the triangle. Cllr Hartnell reported he hasn't yet checked the salt bins but will do so.

**2025.85 To receive reports:** Cllr Power's report has been forwarded. There will be a final decision next month on the Somerset Boundaries. There is to be a change in delivery days on some green garden waste bins, 45,000 bins when they started – now up to 60,000 so rearranging collections. Transformation has started they have to make savings of £190m. The Planning emergency is over, they have 1600 applications down to 1200. Lucy and Tom are only allowed to use one email address to contact planning and Highways are not responding to them at all.
